Additional Information:

We recommend scheduling several months prior to your wedding date to reserve your appointments.

On the day of the wedding... Please have everyone wear a button-down shirt. If you or your bridal party has scheduled an up-do, shampoo and dry your hair using mousse or gel the day before your appointment (this ensures the longevity of the style). If you must shampoo on the day of the wedding, apply a small amount of styling products before you blow dry. Do not use a heavy conditioner. **Your hair must be COMPLETELY DRY when you arrive if you are doing an up do.** PLEASE DO NOT USE A FLATIRON ON YOUR HAIR IF IT IS GOING TO BE WORN UP! *For those having blow-dry, when receiving services in the salon we will shampoo your hair. If coming to your location, please shampoo your hair prior to our arrival.*

If you are having makeup done, the face must be 100% makeup free. Please pre-cleanse and moisturize

your skin thoroughly before our arrival. ****False eyelash applications are \$20****

Our salon requires a minimum of 4 services required **per** stylist(initials_____)

A \$200 deposit is required to reserve your wedding date and stylist's time. Payable by check, cash, Venmo or PayPal, or credit card (initials_____)

The above information is imperative in determining how many stylists will be required for your wedding party and for scheduling our time accordingly. **Should any member of the wedding party that we have on contract not make their appointment, below signer is still liable for the cost of the contracted services.** (initials____)

Consider scheduling a "trial run" of your makeup and hairstyle using your headpiece prior to your wedding date. This will give you a sense of comfort with the hairstyle and will provide an estimate of how much time is necessary to style your hair. Trial runs done at the salon are \$125/hour(initials____)
